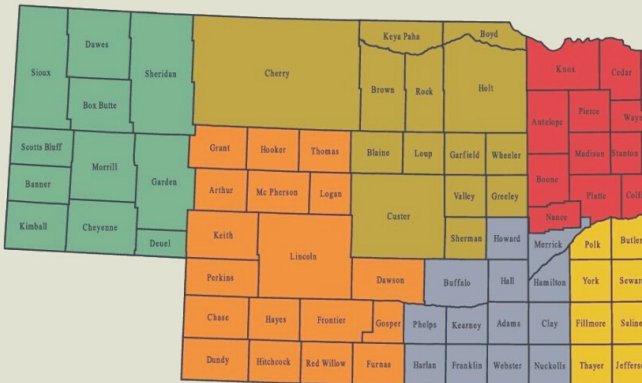

- An Economic Development District designated by EDA in 1985 and 1 of 8 in the state

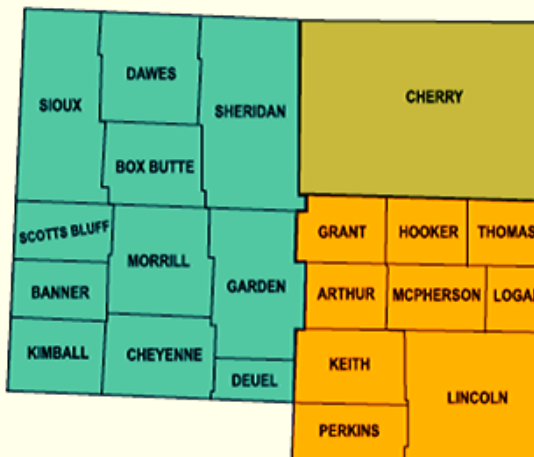
WE ARE NOT...

ECONOMIC DEVELOPMENT LOAN FUND

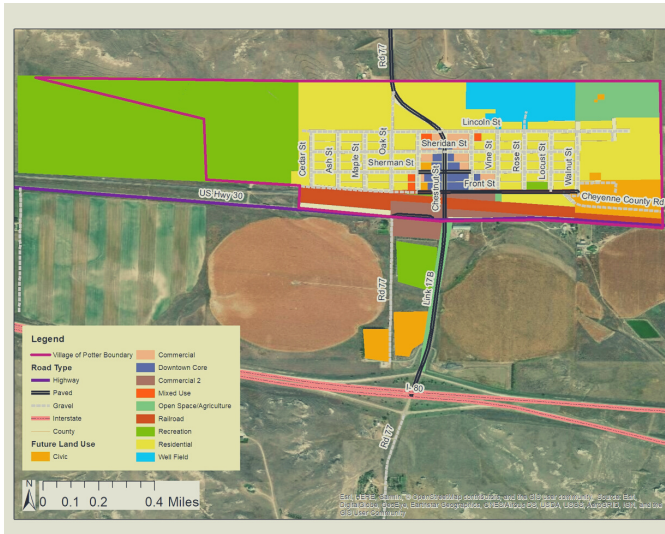
- Available to new or existing businesses who are working with a bank or economic development entity, is in a community that is a member of PADD, and has a business plan
- Can provide direct or gap funding
- Can assist with the following:
 - Expansion
 - Transfer of ownership
 - Purchase of assets
 - Inventory
 - Vehicles for business purposes
 - Real Estate
 - Small Working Capital loans (less than \$100,000)
 - Machinery
 - Government Infrastructure and buildings
 - Equipment and more!
